BUSINESS LICENSE OPERATING CONDITIONS

Re: L279 50052 SOUTH SIDE ELECTRONICS for SECOND HAND GOODS

1. The lawful hours of operation are Sunday to Thursday 6:00 a.m. to 10:00 p.m. and Friday and Saturday 6:00 a.m. to 11:00 p.m.
2. The business premises of Southside Electronics shall be clearly defined from the Cup Food business premises. Southside Electronics shall not have a seating area within their licensed premises.
3. Ahmad Abumayyaleh, dba Southside Electronics, and his employees shall use all reasonable efforts to prohibit the sale, distribution or use of illegal drugs on his business premises. Any person found selling, distributing, or using illegal drugs shall be trespassed from the property.
4. Any customer/patron of Southside Electronics that attempts to sell a stolen item shall be trespassed from the store. Each incident shall be reported to Minneapolis Police.
5. Ahmad Abumayyaleh shall conduct criminal background checks on all employees. Any employee determined to have a criminal history for controlled substances or stolen good shall not be employed if the conviction/sentence has not been served as determined by the criteria set in Minnesota Statute 364.03.
6. Ahmad Abumayyaleh shall not use employees of Cup Foods to conduct business for Southside Electronics during their hours of operation. Cup Food and Southside Electronics shall conduct business completely independent of the other business.
7. Southside Electronics shall only allow customers of their business to be present in the licensed premises. All others shall be considered trespassing and requested to

leave. The business shall use 9-1-1 if persons are in their licensed business premise that are not conducting business.

8. Southside Electronics shall limit the purchase of second hand goods to computers and phones. If the business wishes to add other items to this list, they must file a request to change their business plan with the Licenses and Consumer Services Division and must obtain approval by the Minneapolis City Council.
9. Southside Electronics shall follow all requirements of the automatic pawn reporting system. Violations of the policies and rule of this system shall be cause for adverse license action.
10. Ahmad Abumayyaleh shall be present at least eight hours each day of business operation or have a designated manager in charge and enforcing all provisions of this license.
11. In cooperation with Minneapolis Police Third Precinct, Southside Electronics shall establish post and enforce a dress code to discourage gang activity from occurring on their premises. This code shall be posted within two weeks of the business license being issued.

I have read the conditions listed above. I agree with the conditions and understand that failure on our part or on the part of my company or employees to adhere to these conditions, may be cause for future adverse license action, including the suspension, revocation, or denial of the renewal of the L279 50052 SOUTH SIDE ELECTRONICS license. These conditions will be effective for the duration the license operates at these premises, unless otherwise amended by the City Council of Minneapolis.


