## **Background/Supporting Information**

The City of Minneapolis has not completed a wholesale survey/audit (of its owned and occupied buildings and associated sites) for Americans with Disabilities Act compliance since 1995. The intent of the current project is to complete a comprehensive survey/audit to identify deficiencies, options for resolution and an estimated cost for each identified deficiency and to create a compliance plan until needed improvements can be funded and implemented.

The City of Minneapolis owns and operates a variety of buildings including office buildings, police precincts, fire stations, public works facilities, parking ramps/garages (including connecting skyways and tunnels) and specialty buildings such as the Animal Care and Control facility. The buildings range in age from over 100 years old to newly constructed. A total of 58 buildings were included in the RFP. Some buildings were not included due to the nature of the building (such as the majority of the Water Works facilities), and others were excluded because they had recently been surveyed separate from this comprehensive survey (for example the Minneapolis Convention Center and the Traffic Maintenance Facility at Border Ave).

The facilities to be included in the Project are limited to the City's buildings used for Municipal Operations and does not include Transit facilities, Park facilities, Schools or Libraries as these facilities are not owned or operated by the City of Minneapolis.

In advance of issuing the RFP, the evaluation committee sought and received input and guidance from the Mayor's Committee on People with Disabilities. The City received seven proposals in response to the RFP, and three firms were interviewed.

The evaluation panel is recommending awarding the contract to JQP, Inc., for an amount not to exceed \$100,000. JQP, Inc. is a woman owned firm that specializes in accessibility. This firm was certified (as a woman owned business) by the Civil Rights Department at their July 23, 2014 meeting.
