At the license settlement conference held on Monday, November 26, 2007 the Division of Licenses and Consumer Services discussed the evidence that the City of Minneapolis presented regarding the violations at your establishment and our recommendation for revocation. 





This letter is to give notice of a license settlement conference to be held on Friday, November 16, 2007 at 2:30 p.m. in Room 1C City Hall 350 South 5th Street regarding the revocation of the On-Sale Liquor, Class E, with Sunday Sales license held by FUNHOUSE Inc, dba Johnny A's.


The recommendation for revocation is based on the following:

1. That on January 18, 2007 the Office of the Hennepin County Attorney notified the licensee and owner of the property at 200 West Broadway that this property and establishment were considered a Public Nuisance. This is a violation of Minnesota Statue 617.80.
2. That on April 25, 2007 during a search warrant of the premises and parking lot conducted by the MN Gang Strike Force that resulted in 14 persons arrested for narcotics case #07-131145. This is a violation of Minneapolis Ordinance 259.250 (1) I.
3. That on May 17, 2007 the licensee was on the no ship list for nonpayment of Minnesota State Sales Tax. An inspection by Minneapolis Licensing and the State AGE found evidence of alcohol that was purchased illegally. At this inspection the licensee admitted to obtaining the alcohol illegally with the intent to resell the alcohol to the public. This is a violation of Minnesota Statue 340A.415 and 7515.0520 and Minneapolis Ordinance 362.500.
4. That on May 22, 2007 the licensee could not produce documentation that he had legally obtained the alcohol that was on the premises for resale and the alcohol had been removed and property inventoried. The licensee stated that the value of the alcohol removed was approximately \$30,000.00. This is a violation of Minnesota Statue 340.415 and 7515.0520 and Minneapolis Ordinance 362.500.
5. That on October 1, 2007 the licensee failed to remit the second-half payment for the annual license fee. This is a violation of Minneapolis Ordinance 362.90.
6. That on October 28, 2007 the licensee failed to maintain liquor liability insurance and was cancelled by the licensee's insurance company for nonpayment of premium. This is a violation of Minnesota Statue 340A.409 and Minneapolis Ordinance 362.150.

7. That as of October 30, 2007 the licensee has failed to make payment of the citation 07-0564932 issued for violating MN Statue 340A.415 and 7515.0520 that was due June 7, 2007. This is a violation of Minneapolis Ordinance 259.15.

If you desire, legal counsel may represent you at the hearing. Failure to appear may jeopardize your license. If you have any questions, please contact District Supervisor Linda Roberts, 612-673-3908.

259.250. Business license management responsibilities. The following minimum standards and conditions shall be met in order to hold a license, provisional license or permit under Titles 10, 13 and 14 of this Code. Failure to comply with any of these standards and conditions shall be adequate grounds for the denial, refusal to renew, revocation or suspension of said license or permit.

- (1) It shall be the responsibility of the licensee to take appropriate action to prevent further violations following conduct by any persons on the business premises, including parking areas, in violation of any of the following statutes or ordinances:
 - a. Minnesota Statutes, Sections 609.75 through 609.76, which prohibit gambling.
 - b. Minnesota Statutes, Sections 609.321 through 609.324, which prohibits prostitution and acts relating thereto.
 - c. Minnesota Statutes, Sections 152.01 through 152.025 or Section 152.027 subdivisions 1 and 2, which prohibit the unlawful sale or possession of controlled substances.
 - d. Minnesota Statutes, Sections 617.23 through 617.241, which prohibits indecent exposure and the exhibition and distribution of obscene materials or performances.

- (7) Vending and other unattended coin operated machines shall be in plain view of employees and shall not be operable during hours the business is not open to the public and in operation. Public pay telephones shall be operated in full compliance with Chapter 264 of this Code.
- (8) Parking and other outdoor areas of the premises accessible to the public shall be illuminated at an intensity of at least two (2) foot-candles per square foot at eighteen (18) inches above ground level.
- (9) The provisions of this section are not exclusive. Adverse license action may be based upon good cause as authorized by Chapter 4, Section 16 of the Charter. This section shall not preclude the enforcement of any other provisions of this Code or state and federal laws and regulations. (2001-Or-121, § 1, 10-26-01; 2006-Or-098, § 9-1-06)

Subd. 7. **Inspection.** An establishment holding a permit under this section is open for inspection by the commissioner and the commissioner's representative and by peace officers, who may enter and inspect during reasonable hours. Intoxicating liquor sold, served, or displayed in violation of law may be seized and may be disposed of under section 297G.20.

Subd. 8. **Lockers.** A club issued a permit under this section may allow members to bring and keep a personal supply of intoxicating liquor in lockers on the club's premises. All bottles kept on the premises must have attached to it a label signed by the member. No person under 21 years of age may keep a supply of intoxicating liquor on club premises.

Subd. 9. **One-day city permits.** A city may issue a one-day permit for the consumption and display of intoxicating liquor under this section to a nonprofit organization in conjunction with a social activity in the city sponsored by the organization. The permit must be approved by the commissioner and is valid only for the day indicated on the permit. The fee for the permit may not exceed \$25. A city may not issue more than ten permits under this section in any one year.

No license shall be granted, maintained, or renewed, for operation on any premises, on which taxes, assessments or other financial claims of the city or of the state are due, delinquent or unpaid. In the event an action has been commenced pursuant to the provisions of Chapter 278, Minnesota Statutes, questioning the amount or validity of taxes, the council may, on application by the licensee, waive strict compliance with this provision; no waiver may be granted, however, for taxes or any portion thereof, which remain unpaid for a period exceeding one (1) year after becoming due unless a payment plan has been entered into or the liability is under litigation or appeal. To Whom It May Concern:

Public records indicate that you own, manage, and/or have a possessory interest in the property located at 200 West Broadway, Minneapolis, Minnesota. The Minneapolis Police Department and citizens in the community have expressed concern that illegal activity is taking place in or around this property. It has recently come to the attention of the Hennepin County Attorney's Office that there has been at least one incident of illegal activity at this address.

The Hennepin County Attorney's Office is hereby informing you that a "nuisance" is defined in the Public Nuisance Statute (Minn. Stat. §617.80 et. Seq.) as follows:

Subd.2. "ACTS CONSTITUTING A NUISANCE"

"two or more separate behavior incidents of one or more of the following, committed within the previous 12 months within the building, or if the building contains more than one rental unit: (1) within a single rental unit; or (2) within two or more rental units leased or controlled by the same person:

- (1) prostitution or prostitution-related activity committed within the building;
- (2) gambling or gambling-related activity committed within the building;
- (3) maintaining a public nuisance in violation of section 609.74, clause (1) or (3);
- (4) permitting a public nuisance in violation of section 609.745;
- (5) unlawful sale, possession, storage, delivery, giving, manufacture, cultivation, or use of controlled substances committed within the building;

- (6) unlicensed sales of alcoholic beverages committed within the building in violation of section 340A.401;
- (7) unlicensed sales or gives of alcoholic beverages by an unlicensed person committed within the building in violation of section 340A.503, subdivision 2, clause (1);
- (8) unlawful use or possession of a firearm in violation of section 609.66, subdivision 1a, 609.67, or 624.713, committed within the building;


The following incident(s) have occurred on your property:

1. Between January 30, 2006, and December 24, 2006, Minneapolis Police officers have been called to the address 243 times. These calls have been for persons with a gun, suspicious persons, threats, domestics, shots fired, assaults, robberies, narcotics, and additional miscellaneous calls.
2. On November 18, 2006, Minneapolis Police officers observed a narcotics transaction in the parking lot. One of the people involved admitted to being a bouncer at the address.
3. On October 17, 2006, a fight occurred inside the address and continued out in the parking lot.
4. On October 6, 2006, a group of people got into an argument and went outside to fight. Security at the address admitted to removing the parties from inside the address to the parking lot.
5. On September 15, 2006, Minneapolis Police officers conducted a controlled buy of narcotics in the parking lot of the address, the seller then went inside the address.
6. On August 15, 2006, Minneapolis Police officers observed a narcotics transaction in the parking lot of the address. The people involved then went inside the address.
7. On July 20, 2006, Minneapolis Police officers observed several hand to hand narcotic transactions. Officers found one person inside the address, flushing narcotics down the toilet.
8. On June 2, 2006, Minneapolis Police officers observed narcotics transactions in the parking lot of the address.

We are putting you on notice as the owner or landlord of this property: 200 West Broadway, Minneapolis, Minnesota is a public nuisance as defined by the statute. You are required to abate any nuisance that may exist as well as institute measures that will insure that your property will not maintain problems in the future. This letter is a notice to abate the nuisance at 200 West Broadway, Minneapolis, Minnesota. After you receive this letter, you have thirty days to correct the problems and abate the nuisance. If the problem is not resolved within thirty days of receiving this notice to abate the nuisance, the County may file a complaint in district court that could, among other remedies, result in enjoining the use of the building for any purpose for one year, or, in the case of a tenant, could result in cancellation of the lease. As a landlord you may be entitled to several options regarding the cancellation of a tenant's lease under Minn. Stat. §617.85. (See attached copy of the law.)

We trust that you share our concern in eliminating this activity in the community and will take appropriate steps to eliminate the nuisance at your property. Please contact our offices so that we may coordinate the abatement of the problems on your property. I can be reached at 612-348-2666.

We have been advised that your business has been placed on the State of Minnesota liquor posting list by the Minnesota Department of Revenue. While on this list you are not permitted to receive wholesale deliveries of beverage alcohol products. Please be advised that retail purchase of beverage alcohol by another retailer is a violation of Minnesota Statute. Random inspections of your beverage alcohol supplies will be conducted to ensure that unlawful alcohol purchases are not occurring.

Inspector's Comments:

On Thursday, May 17, 2007 Inspector Roberts and Inspector Schliesman from Minneapolis Licenses and Consumer Services; Liquor Field Agent Mueller, Minnesota Department of Public Safety; and Officer Rodriguez Minneapolis Police Licensing conducted an inspection at this establishment to ensure that there were no unlawful purchases of alcohol because the establishment has been on the Minnesota Department of Revenue posting since November 2006. The inspection resulted in finding unlawful purchases of alcohol. The licensee and 100% shareholder, John Alexander, admitted that he has been purchasing alcohol from liquor stores.

Funhouse Incorporated doing business as Johnny A's 200 Sports Bar & Grill in Minneapolis MN has been posted on the MN Department of Revenue Liquor Posting since November 15, 2006. Once posted a retailer is prohibited from receiving alcohol product from wholesale distributors.

S/I Mueller was contacted by the Minneapolis Licensing Division and his assistance was requested in a check of the licensee's alcohol product in an effort to determine if the product was delivered to or brought into the licensed premises in violation of MN Liquor Chapter 340A.

Mueller met with Minneapolis Licensing officials Linda Roberts and Phil Schliesman at Minneapolis City Hall at 13:00 hours on May 17, 2007. Accompanied by a Minneapolis Police Officer, the representatives of Minneapolis Licensing and Mueller entered Johnny A's 200 Sports Bar & Grill at approximately 13:30 hours through a public entrance accessed from the parking lot of the business. Roberts and Mueller approached the bar and an unidentified female employee was asked if owner, Johnny Alexander was present, she stated he was not. Both Roberts and Mueller presented their business cards and verbally identified themselves and the government entities they represent. Mueller requested the bartender contact Mr. Alexander and ask him to come to the bar, which the female did.

While waiting for Alexander to arrive, Mueller requested and was granted permission, from the female employee, to check the malt beverage and liquor inventories located at the bar. During the check Mueller and Schliesman located a large quantity of malt beverage product with production/fill dates well after the November 20, 2006 date of last legal delivery. A single bottle of Budweiser, Michelob Golden Light, Miller Genuine Draft and Corona were removed from the coolers and inventoried by Schliesman. Mueller also conducted a quick check of the distilled spirits product located on the bar's speed rail and located a 750 ml bottle of Jose Cuervo Tequila also with a production date after the November 20, 2006. The single bottle of tequila was inventoried by Schliesman.

Bar owner, John Alexander arrived at the bar at approximately 13:45 hours and questioned the reason for the inspection. Roberts and Mueller explained to him that the business has been posted by the MN Department of Revenue for failure to pay taxes since November 15, 2006. Mueller asked Alexander if any distilled spirits, wine or malt beverage wholesalers have delivered to the business since November 20th, 2006, Alexander said none had. Mueller then asked where the beer and liquor had come from and Alexander stated, "I've been going to a lot of liquor stores." When asked which liquor stores Alexander replied, "A lot of them." Asked if the liquor stores knew that the product was going to be resold in a bar Alexander said, "No, they don't know." Mueller requested he be shown where the kegs of beer were located and Mr. Alexander led Mueller, Roberts and Schliesman to a cooler located in the basement. Mueller checked the kegs and found them all to have production/fill dates well after the November no ship date. It was noted that none of the kegs had keg registration tags attached, as required when selling a keg at retail. Mueller asked Alexander where the kegs had come from and was told that the empty kegs would be brought to various bars in Minneapolis and switched with a full keg. Alexander stated that he had a lot of friends in the business and they were helping him out by getting the kegs for him. Mueller questioned why Alexander didn't go to liquor stores and was told that he didn't want any "tagged" kegs in his cooler. Mueller advised that Alexander's friends were jeopardizing their liquor

licenses by acting as a wholesaler of liquor without a license, as well as selling alcohol at off-sale without a license. Mueller asked Alexander if he was working with the Department of Revenue in paying the owed taxes and he stated he was and that he hoped to pay the owed amount by June 1, 2007. Mr. Alexander showed Mueller a letter from the Department of Revenue regarding the matter. Ms. Roberts asked if she could see the letter and Alexander informed her that he would work with the state, but not the city. He went on to say the city of Minneapolis is trying to ruin the bar business and he, along with other bar owners were going to fight such an effort. He apologized to Roberts and Schliesman, stating that he knew they were doing their job and they work hard, but he isn't going to provide any information to the city because of the politics involved.

Upon returning to the main floor of the bar Mr. Schliesman asked Alexander where the bottles of beer and tequila had come from and was told they were purchased at a liquor store. Mueller advised Alexander to discontinue the practice of buying at retail with the intent of reselling the alcohol. Mueller further advised that Alexander needed to immediately discontinue getting his kegged beer from other bars as well. Schliesman then presented the city of Minneapolis inventory sheet to Alexander and requested a signature indicating the 4 bottles of beer and tequila were being removed as evidence of a liquor violation.

The city licensing officials, the Minneapolis Police Officer and Mueller cleared the bar at approximately 14:15 hours.

Mueller's involvement was only to assist in the deciphering of production dates and codes on the various liquor products. The entire matter is being handled by the Minneapolis Licensing Division, with no further action necessary by the Alcohol and Gambling Enforcement Division.

This agent would recommend the case be closed as an Assist and Advise.

Acting in this capacity, I give the following information.

During the past months your affiant has become aware of increasingly heavy drug trafficking involving Johnny A's bar 200 W. Broadway, Approximately 5 months ago your affiant did surveillance from a storage building that overlooks the rear lot and main door and Officers saw 4 drug transactions and called in marked squads, which placed the persons under arrest and recovered marijuana and crack cocaine. The doorman observed officers in the windows and alerted the customers and pointed Officers out to other drug sellers,

Officers returned the next night and found that someone had shot paintballs all over the windows they were using for an observation post,

Several months ago Gang Officers arrested Tryrebi Leak in possession 12 grams of crack cocaine while he was sitting at Johnny As. The CRI who provided information leading to his arrest stated that it is common knowledge that anyone can buy marijuana or crack at Johnny's As and that they employees are involved in the drug trafficking.

Recently, 04152007 your affiant and Officer Schany in plainclothes drove into the lot at Johnny as and observed a male talking to the bouncer. This male then turned towards officers and approached us and asked if we needed something and asked "Are you Straight" which means are you not the Police and do want drugs.

On 04172007 Gang Officers Nimlos and Schany observed a male run into the bar and carrying a laptop and leaving empty-handed. 
This letter is to inform you of the investigation our department has been conducting on your business. There is significant and convincing evidence that this establishment does not meet the minimum standards to operate as an off sale liquor establishment. We are preparing to schedule a revocation action before Council for which formal notice will be mailed to you within 10 days of the action.

Revocation action is being initiated based on repeated instances of criminal nuisance and narcotics activity at the premises as well as admitted and documented license violations dealing with illegal no-ship alcohol purchases and sales. The division is additionally prepared to simultaneously refer to the city attorney for criminal prosecution evidence of multiple violations of state law governing no-ship alcohol purchases and sales.

You have made requests through your attorney for the contraband seized during the search warrant of May 22, 2007; our division will not release this evidence as long as there are criminal and civil charges pending. MINNEAPOLIS, MINNESOTA.

To Whom It May Concern:

Public records indicate that you own, manage, and/or have a possessory interest in the property located at 200 West Broadway, Minneapolis, Minnesota. The Minneapolis Police Department and citizens in the community have expressed concern that illegal activity is taking place in or around this property. It has recently come to the attention of the Hennepin County Attorney's Office that there has been at least one incident of illegal activity at this address.

The Hennepin County Attorney's Office is hereby informing you that a "nuisance" is defined in the Public Nuisance Statute (Minn. Stat. §617.80 et. Seq.) as follows:

Subd.2. "ACTS CONSTITUTING A NUISANCE"

"two or more separate behavior incidents of one or more of the following, committed within the previous 12 months within the building, or if the building contains more than one rental unit: (1) within a single rental unit; or (2) within two or more rental units leased or controlled by the same person:

- (1) prostitution or prostitution-related activity committed within the building;
- (2) gambling or gambling-related activity committed within the building;
- (3) maintaining a public nuisance in violation of section 609.74, clause (1) or (3);
- (4) permitting a public nuisance in violation of section 609.745;

- (5) unlawful sale, possession, storage, delivery, giving, manufacture, cultivation, or use of controlled substances committed within the building;
- (6) unlicensed sales of alcoholic beverages committed within the building in violation of section 340A.401;
- (7) unlicensed sales or gives of alcoholic beverages by an unlicensed person committed within the building in violation of section 340A.503, subdivision 2, clause (1);
- (8) unlawful use or possession of a firearm in violation of section 609.66, subdivision 1a, 609.67, or 624.713, committed within the building;

The following incident(s) have occurred on your property:

1. On February 14, 2007, Minneapolis Police officers conducted a suspicious vehicle stop in the parking lot of the listed address. The parking lot is clearly marked with No Trespassing and No Loitering signs. One person was cited with possession of narcotics.
2. On February 18, 2007, Minneapolis Police officers conducted a suspicious vehicle stop in the parking lot of the listed address. The parking lot is clearly marked with No Trespassing and No Loitering signs. One person was cited for possession of narcotics.
3. On March 9, 2007, a controlled buy was conducted in the parking lot of the listed address where U.S. Currency was exchanged for narcotics. Two people were arrested and transported to the Hennepin County Jail.
4. On March 9, 2007, a Minneapolis Police officer was propositioned by a known prostitute in the parking lot of the listed address. One person was arrested and transported to the Hennepin County Jail.
5. On March 9, 2007, Minneapolis Police officers observed a hand to hand exchange of narcotics and U.S. Currency in the parking lot of the listed address. One person was cited for loitering and released. The second person (seller) fled into the crowded bar and could not be identified.
6. On March 9, 2007, a citizen informant notified the Minneapolis Police Department that a patron of the bar was dealing narcotics to other patrons. One person was cited for narcotics possession.
7. On March 17, 2007, Minneapolis Police officers observed a suspicious vehicle in the parking lot of the listed address. One person was arrested for narcotics possession and transported to the Hennepin County Jail.
8. On March 17, 2007, Minneapolis Police officers responded to a report of a person with a gun whom had entered the listed address. The owner of the listed address pulled his personal handgun, which he has a permit to carry, and pointed it at the suspect. The suspect fled the scene while shooting in an unknown direction.
9. On March 20, 2007, Minneapolis Police officer observed a person in the parking lot of the listed address remove a gun from a vehicle, place it in his front waistband and enter the listed address. One person was arrested for narcotics possession and transported to the Hennepin County Jail.

10. On March 20, 2007, Minneapolis Police officers observed a person loitering in the parking lot several times over a three hour period. The parking lot is clearly marked with No Trespassing and No Loitering signs. One person was cited for loitering and possession of narcotics.
11. On March 24, 2007, Minneapolis Police officers conducted a walk through at the listed address. While officers approached the listed address, a patron standing near the entrance pushed past the bouncer and into the bathroom. Officers followed this person into the bathroom where they observed a strong odor of marijuana and two persons trying to flush narcotics down the toilet. Two people were arrested for narcotics possession and transported to the Hennepin County Jail.
12. On March 24, 2007, while Minneapolis Police officers responded to a related call, one person was arrested for loitering and narcotics possession in the parking lot of the listed address.
13. On March 28, 2007, Minneapolis Police officers arrested one person in the parking lot of the listed address for an open container of alcohol in a vehicle and narcotics possession.
14. On April 4, 2007, Minneapolis Police officers observed a hand to hand exchange of narcotics and U.S. Currency in the parking lot of the listed address. Two people were cited for loitering and released.
15. On April 5, 2007, Minneapolis Police officers observed two people loitering behind the listed address. One person was cited for possession of drug paraphernalia.
16. On April 20, 2007, Minneapolis Police officers observed a person urinating behind the listed address. As officers approached the suspect dropped narcotics onto the ground. This person was arrested for narcotics possession and transported to the Hennepin County Jail.
17. On April 22, 2007, a female victim was assaulted inside the listed address by an unknown suspect whom fled the location. Victim declined EMS.
18. On April 25, 2007, the Metro Gang Strike Force along with the Minneapolis Police Department executed a narcotics search warrant at the listed address. Twelve people were arrested for narcotics possession and one person for gun possession. One of the twelve people arrested for narcotics was employed by Johnnie A's.
19. On April 30, 2007, Minneapolis Police officers observed two people loitering in the parking lot of the listed address. Two people were cited for loitering to buy/sell narcotics.
20. On May 2, 2007, conducted a traffic stop in the parking lot of the listed address. One person was arrested for narcotics possession and transported to the Hennepin County Jail.
21. On May 9, 2007, Minneapolis Police officers observed three people loitering in the parking lot of the listed address. One person was picked up on an active warrant and a second person was cited for possession of drug paraphernalia.
22. On May 13, 2007, Minneapolis Police officers approached a vehicle occupied by two males with a female leaning into the passenger window in the parking lot of the listed address. One person was observed trying to hide a black plastic bag between the seat and center console. Two people were arrested for narcotics possession and transported to the Hennepin County Jail.

23. On May 22, 2007, the Metro Gang Strike Force along with the Minneapolis Licensing Division executed a search warrant at the listed address in order to seize illegally obtained alcohol that the business was selling retail. During the execution of the search warrant, Minneapolis Police officers observed a patron throw narcotics onto the ground. One person was arrested for narcotics possession and transported to the Hennepin County Jail.
24. On May 30, 2007, Minneapolis Police officers observed two people loitering behind the listed address. One person was cited for possession of drug paraphernalia.
25. On June 8, 2007, Minneapolis Police officers observed an individual walking between the listed address and another bar numerous times. This individual was arrested for narcotics possession and transported to the Hennepin County Jail.
26. On June 7, 2007, Minneapolis Police officers responded to an assault call at the listed address. An employee of Johnnie A's confronted a patron inside the business. The patron dropped a gun and fled the scene. Gun was recovered and given to a Minneapolis Police officer.
27. On June 9, 2007, Minneapolis Police officers observed suspicious activity at the entrance of the listed address. An individual was approaching patrons as they entered and exited the business and showing them unknown objects in a bag. The bag contained several bottles of unopened expensive cologne along with narcotics. This person was arrested for narcotics possession and transported to the Hennepin County Jail.
28. On June 20, 2007, Minneapolis Police officers observed two people loitering behind the listed address. Two people were arrested for narcotics possession and transported to the Hennepin County Jail.
29. On June 21, 2007, Minneapolis Police officers observed one person loitering in the back of the listed address. This person was cited for possession of drug paraphernalia.
30. On June 23, 2007, Minneapolis Police officers observed an individual loitering in the parking lot of the listed address. He was approaching other individuals and showing them the contents of a bag. Upon noticing the officers this individual fled into the bar and tossed the baggie onto the floor. He was arrested for narcotics possession and transported to the Hennepin County Jail.
31. On June 28, 2007, Minneapolis Police officers observed two people loitering in the rear of the listed address. Both people were arrested for loitering with the intent to buy/sell narcotics and transported to the Hennepin County Jail.
32. On June 28, 2007, Minneapolis Police officers observed an individual loitering in the rear of the listed address. He was cited for possession of drug paraphernalia.
33. On August 4, 2007, Minneapolis Police officers were dispatched to the listed address on a call for a person with a gun. An individual matching the description of the suspect was searched in the parking lot. This individual was arrested for narcotics possession and transported to the Hennepin County Jail.
34. On October 31, 2007, Minneapolis Police officers were dispatched to the listed address on a call for a person with a gun. When officers arrived a vehicle was observed leaving the parking lot at a high rate of speed. Vehicle was stopped and two people were arrested for narcotics possession and transported to the Hennepin County Jail.

35. On November 1, 2007, Minneapolis Police officers observed an individual trying to hide inside a vehicle located in the parking lot of the listed address. Officers observed a two foot sword under the seat. One person was cited for weapons violation.
36. On November 2, 2007, Minneapolis Police officers were dispatched to a shooting call at the listed address. Victim was shot while standing outside of the North side door. Victim was transported to HCMC. Case remains open.
37. On November 23, 2007, a female was assaulted by an employee of Johnnie A's whom is the D.J. The suspect fled the scene.
38. On December 5, 2007, Minneapolis Police officers responded to a call by the owner of listed address who found narcotics behind a phone book.
39. On December 27, 2007, Minneapolis Police officers observed an individual loitering in the parking lot of the listed address. This individual was cited for loitering with intent to buy narcotics after admitting he was at this location to purchase marijuana.
40. On January 3, 2008, Minneapolis Police officers were flagged down by the owner of the listed address as he was trying to remove an individual who was trespassed from the property. This individual was cited for possession of drug paraphernalia.
41. On January 11, 2008, Minneapolis Police officers observed narcotics transactions in the parking lot of the listed address. Three people were arrested for open bottle, loitering with intent to buy/sell narcotics and possession of drug paraphernalia.
42. On January 13, 2008, Minneapolis Police officers were dispatched to a narcotics call at the listed address. The suspected vehicle was stopped. One person was arrested for possession of narcotics and transported to the Hennepin County Jail.
43. On January 18, 2008, Minneapolis Police officers observed two individuals selling bootlegged DVD's to individuals in the parking lot of the listed address. One individual was cited for license violation and the other individual was arrested for five outstanding warrants.
44. On January 23, 2008, representatives of the Minnesota Gambling Control Board, Minnesota Department of Public Safety – Alcohol and Gambling Enforcement Division, Minneapolis Regulatory Services – License Inspections and the Minneapolis Police Department participated in an unannounced onsite inspection at the listed address. An unlawful Texas Hold 'em tournament was advertised in the bar with a \$1000 cash prize. The advertisement was confiscated by an agent of the DPS AGE Division.
45. On January 26, 2008, Minneapolis Police officers arrested an individual in the parking lot of the listed address whom had an active warrant. Prior to transport this person was searched and found to be in possession of narcotics.
46. On February 2, 2008, Minneapolis Police officers observed two individuals loitering in the parking lot of the listed address. One person was observed making two hand to hand exchanges of narcotics for U.S. Currency. After noticing the officers, this person was observed throwing unknown items into the alley. Due to the debris in the alley, the items were not recovered. This person was cited for possession of drug paraphernalia.

47. On February 4, 2008, Minneapolis Police officers conducted an undercover narcotics purchase inside the listed address. An unidentified patron set up the undercover officer to purchase narcotics from a known drug dealer. Narcotics were later exchanged for U.S. Currency inside the listed address.
48. On February 5, 2008, an undercover Minneapolis Police officer conducted a controlled narcotics purchase inside the listed address with an employee of Johnnie A's. Narcotics were exchanged for U.S. currency.
49. On February 5, 2008, Minneapolis Police officers executed a narcotics search warrant at the listed address. A large quantity of narcotics and U.S. Currency was recovered. Four people were arrested for narcotics possession, one person was transported to the Hennepin County Jail on an active warrant, and two people were cited for loitering with intent.
50. Between February 2007 and February 2008 Minneapolis Police officers have been called to this business 419 times. These calls have been for assaults, narcotics, disturbances, suspicious persons, person with a gun, and other misc. calls.

We are putting you on notice as the owner or landlord of this property: 200 West Broadway, Minneapolis, Minnesota is a public nuisance as defined by the statute. You are required to abate any nuisance that may exist as well as institute measures that will insure that your property will not maintain problems in the future. This letter is a notice to abate the nuisance at 200 West Broadway, Minneapolis, Minnesota. After you receive this letter, you have thirty days to correct the problems and abate the nuisance. If the problem is not resolved within thirty days of receiving this notice to abate the nuisance, the County may file a complaint in district court that could, among other remedies, result in enjoining the use of the building for any purpose for one year, or, in the case of a tenant, could result in cancellation of the lease. As a landlord you may be entitled to several options regarding the cancellation of a tenant's lease under Minn. Stat. §617.85. (See attached copy of the law.)

We trust that you share our concern in eliminating this activity in the community and will take appropriate steps to eliminate the nuisance at your property. Please contact our offices so that we may coordinate the abatement of the problems on your property. I can be reached at 612-348-6919.
