Supporting Information

The 2010 Consolidated Plan is the City's application to the U.S. Department of Housing and Urban Development for the 2010 Community Development Block Grant (CDBG), Home Investment Partnerships (HOME), Emergency Shelter Grant (ESG), Housing Opportunities for Persons with AIDS (HOPWA), and the 2010-14 Five Year Strategy.

A public hearing for the City's FY 2010 Consolidated Plan is scheduled for March 23, 2010 before your committee. The public hearing is required of the City before its submission of the Consolidated Plan to HUD. Any comments received during the Public Hearing or during the March 15-April 13, 2010 public comment period will be included in the City's Consolidated Plan.

On March 15, 2010 a draft version of the 2010 report was made available for public review and comment, and comments will be accepted through April 13, 2010. This allows for a thirty-day review and comment period before staff submits the Plan to HUD. Each year the dollar amounts for the Consolidated Plan grant projects/programs are estimated until HUD provides the actual appropriation. The City expects to receive this in mid-March.
