At a neighborhood-wide meeting held October 1st, 2012, McKinley residents and the McKinley Community board voted to approve the following request for an NRP Phase I-II Plan Modification and 2012-13 Neighborhood Priorities.

1) *Reallocate \$150,000 of program income held by CEE*

From: Phase I, Strategy 1.A.1.1 – Home Improvement Program (\$150,000)

To: Phase II, Strategy 1.C.1.2 – McKinley CSA (\$60,000)
Phase II, Strategy 2.B.1.1 – Staff (\$50,000)
Phase II, Strategy 4.A.1.1 – Create Gardens on Empty Lots (\$40,000)

2) *Reallocate \$35,000 of 2003 funds*

From: Phase I, Strategy 2.B.2.1 – Bike Trails

To: Phase II, Strategy – Staff (\$10,000)
Phase II, Strategy – 3.A.1.1 Speed Bumps (\$5,000)
Phase II, Strategy – 2.A.1.4 Neighborhood Events (\$5,000)
Phase II, Strategy – 1.A.1.1 Home Improvement Loans (\$10,000)
Phase II, Strategy – 1.A.1.2 Blighted Property Acq. & Redevelopment (\$5,000)

3) *Distribute \$23,102 of the 2012 “Equity Funds” to create new 2012-13 Neighborhood Priorities in tandem with to the following approved NRP Phase II strategies:*

Phase II, Strategy – 1.B.1.1 Homebuyer Assistance Program (Phase III NPP – \$1,927)

Phase II, Strategy – 1.C.1.1 Employment Programs (Phase III NPP – \$3,850)
Phase II, Strategy – 2.A.1.2 Semi-Annual Special Events/News Mailings (Phase III NPP – \$1,925)
Phase II, Strategy – 2.A.1.3 Monthly Notices (Phase III NPP – \$1,925)
Phase II, Strategy – 3.A.1.2 Adopt-a-Spot Programs (Phase III NPP – \$1,925)
Phase II, Strategy – 5.A.1.1 Family Move Night (Phase III NPP – \$1,925)
Phase II, Strategy – 5.A.1.2 Support Youth Sports (Phase III NPP – \$1,925)
Phase II, Strategy – 5.A.1.3 Youth Summer Camps (Phase III NPP – \$1,925)
Phase II, Strategy – 5.A.1.4 Teenage Baby Care and Parenting Program (Phase III NPP – \$1,925)

These neighborhood-approved NRP Plan Modifications and Neighborhood Priorities will allow the McKinley neighborhood to shift currently underutilized funds into areas of high neighborhood priority.
