CALLER: I can't tell from the window where I'm at, but.

OPERATOR: Okay. We've got police on the way there right now, okay.

I, I have to leave this location because this gentleman, I believe he's armed, but I just hit a guy with my car that I saw assaulting and robbing a man, um on Nicollet and um he was, he tried to jump onto this guy's scooter and I hit him with my car.

OPERATOR: It happened on Nicollet and 22nd?

CALLER: It, it happened on Nicollet and 22nd, yep.

OPERATOR: And what kind of...

CALLER: Um the...

OPERATOR: Car do you have?

CALLER: I have a Subaru Impreza. I, I had to leave the location. He started, I think he started firing a weapon.

OPERATOR: And where is, is the victim on the ground or?

CALLER: Um he, I hit him in the, the middle of the street. I broke his leg and um he, he's, he, last I saw he was on the street.

OPERATOR: Okay, where are you going to be?

CALLER: I, oh man I, I have to pull over somewhere. I'm, I'm sorry I, I am sorry to leave the scene. I just, I'm, I'm worried, um I'll pull over on...

OPERATOR: We did (inaudible) the report of a shooting from that area so I don't know if that's what also happened or...

CALLER: Yeah, Pillsbury and...

OPERATOR: What color car are you in?

CALLER: I'm in a blue Subaru Impreza, a 2014, um I will pull into, I, I'm very close to my home (inaudible-both parties are talking at the same time)

OPERATOR: Im, Impreza, is that I-M-P-R-E-Z-Z-A, or how do you spell that?

CALLER: Um, I-M-P-R-E-Z-A.

OPERATOR: What is your name?

CALLER: Um **13.82**, ah I'm pulling into, I'm, I'm going a really long distance away. I, I do not want to be anywhere close to that. Um, 24th and, let me jump out and see the corner, 24th and Grand, ah in Minneapolis. Kind of close to Lyndale.

OPERATOR: And you said the person that you hit started shooting or you believe someone else?

CALLER: I believe he started shooting. I, I, I saw him reach into his pocket and then I heard pop and I um, I, I drove away.

OPERATOR: I'm just adding information from the call. I, I completely understand that, that you're going through all the emotions right now, so just stay on the line with me and we're gonna work it out...

CALLER: Oh yeah.

OPERATOR: And everything, okay.

CALLER: Oh, yeah.

OPERATOR: Are you okay? Are you injured at all?

CALLER: I mean I'm not injured. I damaged my car and ah, I ah, yeah I mean it is what it is.

OPERATOR: **13.82** what's your last name?

CALLER: Ah, **13.82** is my last name.

OPERATOR: **13.82**?

CALLER: Yep. I, I, I, I don't know if I should have hit this guy or not but he, like attacked this guy on a scooter and he was, you know, he was like, really, like threatening this guy and he was directly in the line of my vehicle and I just, I just hit him.

OPERATOR: Okay, so it was an intentional because he was...

CALLER: (Inaudible). He was, he was attacking a man. He was, he ran out on the side of the street and body slammed this guy off of the scooter and um, um it was like, directly in front of me and I hit the guy with my car.

OPERATOR: You said that broke his leg? What did they, what did he look like? What race was he?

CALLER: He was um, he was a, a **13.82 - Law Enforcement**

OPERATOR: And he was assaulting one other person?

CALLER: He was assaulting a guy on a scooter, on a, on like a motorized scooter or a, a, you know, like a line scooter or something like that. And right in front of me I see him jump out of the side of the road and body slam the guy on the scooter and it was very obviously that he was trying to either attack him to hurt him or...

OPERATOR: You saw him grab at his waistband?

CALLER: I saw him grab at his waistband, um he ah, then I pulled around the corner, (inaudible) like, oh shit I, I think he's got a gun and I, I pulled away and ah, I heard some pops. It, it sounded like fireworks to me. It didn't sound quite like a gun but it was, it was very loud and it sounded like, you know, it sounded like a gun.

OPERATOR: And where are you right now?

CALLER: I'm pulled into ah, 24th, West 24th Street and Grand Avenue. I'm kind of on the corner there. This happened on like, 22nd and Nicollet. What ah, 22nd and I, I don't know actually the, oh man, um oh man. Maybe it was LaSalle might, it might be LaSalle...

OPERATOR: So you're (inaudible), say that again. You're at, did you say Grand?

CALLER: I'm 22nd, 20, ah I'm so sorry. 24th and ah, Grand. Well I can, you know, give me one moment. I'll look in my Google Maps exactly where this took place.

OPERATOR: Okay.

CALLER: Give me one moment.

OPERATOR: So the last thing you saw is it, did you actually see the gun? You said it also sounded like firecrackers and you weren't sure.

CALLER: Okay, so it was right where um, oh man what is it in (inaudible). I would say between um, Franklin and Blaisdell Avenue where like, um LaSalle turns into Blaisdell.

OPERATOR: (Inaudible) end of it cause we have a, I mean we are getting reports of, there is a shooting that it did end up happening at 22nd and Blaisdell. So I...

CALLER: (Inaudible).

OPERATOR: I do believe that that's probably what had happened. As far...

CALLER: Okay this guy, he can't go very far. I, I broke his leg. It was like his, his foot was like, hanging and um...

OPERATOR: Okay.

CALLER: I pulled, I pulled into a parking lot and I told the woman sitting outside, you need to call the cops. There's, you know, this just occurred and I had to sit, we were, as I told her that I heard some, something that sounded like shots so I just was like, I gotta go.

OPERATOR: And aside from that, you didn't hear anything else or see anything that you know of or that...

CALLER: I heard what appeared to be three shots.

OPERATOR: Okay. I want you to stay where you're at for right now. I just want to make sure that you are safe and that, um I know an officer is going to have to make a report with you, um...

CALLER: Oh yeah.

OPERATOR: (Inaudible) we will, we have your phone number and can get ahold of you if for some reason, we need to have you go to a different location or something. Um, what...

CALLER: Oh, yeah.

OPERATOR: Address do you live at?

CALLER: Um, I live at 13.82 - Law Enforcement

OPERATOR: [REDACTED]?

CALLER: Yes.

OPERATOR: Okay, so you're not too far. Um are you, or, how far are you from home?

CALLER: I'm, I'm very close to home. Honestly I, I could go there.

OPERATOR: Cause I can have a unit, maybe that's fine. I always put that information into the call so I, cause I don't know. Obviously they're gonna have to deal with this situation here. I know you're not injured so we have your information. I appreciate you calling. It sounds like that was a very difficult situation that you were in so, well...

CALLER: Yeah I mean, I, I, I don't know if that, I'm gonna be, you know, in trouble for hitting this guy but it was a, it was very, very like, it happened very quick...

OPERATOR: Sure.

CALLER: And it was very, very obvious from like, you know, from seeing this incident the guy, you know, jumping out and attacking this man, I was like, it happened in the middle of the street so I was just like...

OPERATOR: Sure.

CALLER: Um, yeah sorry. I'm, I may be over explaining this.

OPERATOR: No, no that's okay. I really appreciate it and the details are really helpful. So you are, um you're going to 13.82 - Law Enforcement

Is that a house, apartment duplex?

CALLER: 13.82 - Law Enforcement just call me and, and I can give you my phone number.

OPERATOR: Okay and that is 13.82 - Law Enforcement ?

CALLER: 13.82 - Law Enforcement ...

OPERATOR: Okay.

CALLER: Yes.

CALLER: No I didn't see anyone but (inaudible) been shot, (inaudible) on his back, so. It was three shots just a couple minutes ago. There was one and he look like he might have got hit and got out of his car and then there were two or three more.

OPERATOR: Okay (inaudible-both parties are talking at the same time).

CALLER: (Inaudible-both parties are talking at the same time). Yeah, there's someone shooting out there. It's someone with (inaudible sentences).

CALLER: No, so maybe I should let you go in case someone else calls cause I'm...

CALLER: But now (inaudible-both parties are talking at the same time)...

OPERATOR: What is your name?

CALLER: Oh my God he's still shooting, he's still shooting. He's shooting at (inaudible)...

CALLER: Yeah.

OPERATOR: Want you to stay safe and stay where you feel...

CALLER: I think now there's another car coming at me. I'm trapped, I'm completely trapped.

OPERATOR: Okay, well you stay there where you feel safe. If you're...

CALLER: Okay.

OPERATOR: Trapped just stay in your vehicle. Don't get out, okay.

CALLER: Thank you, yep.

OPERATOR: I got help on the way.

CALLER: Thank you.
