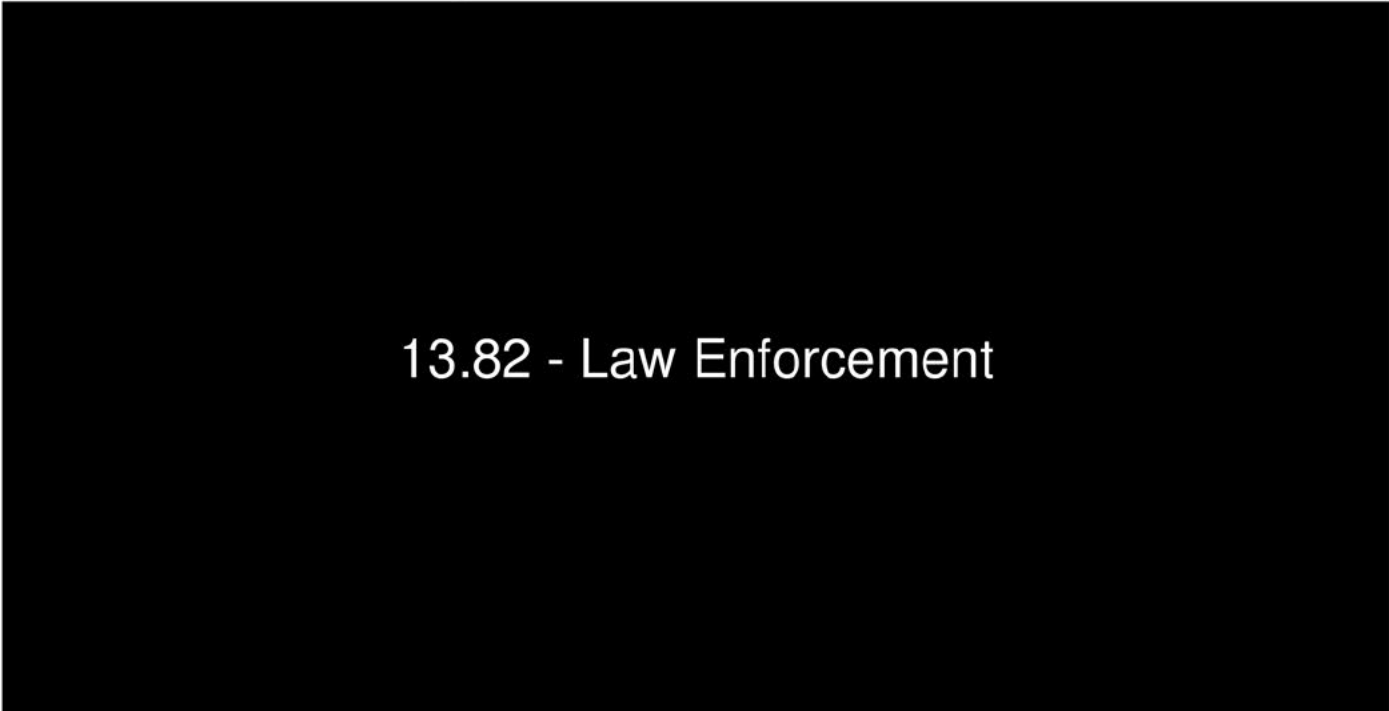

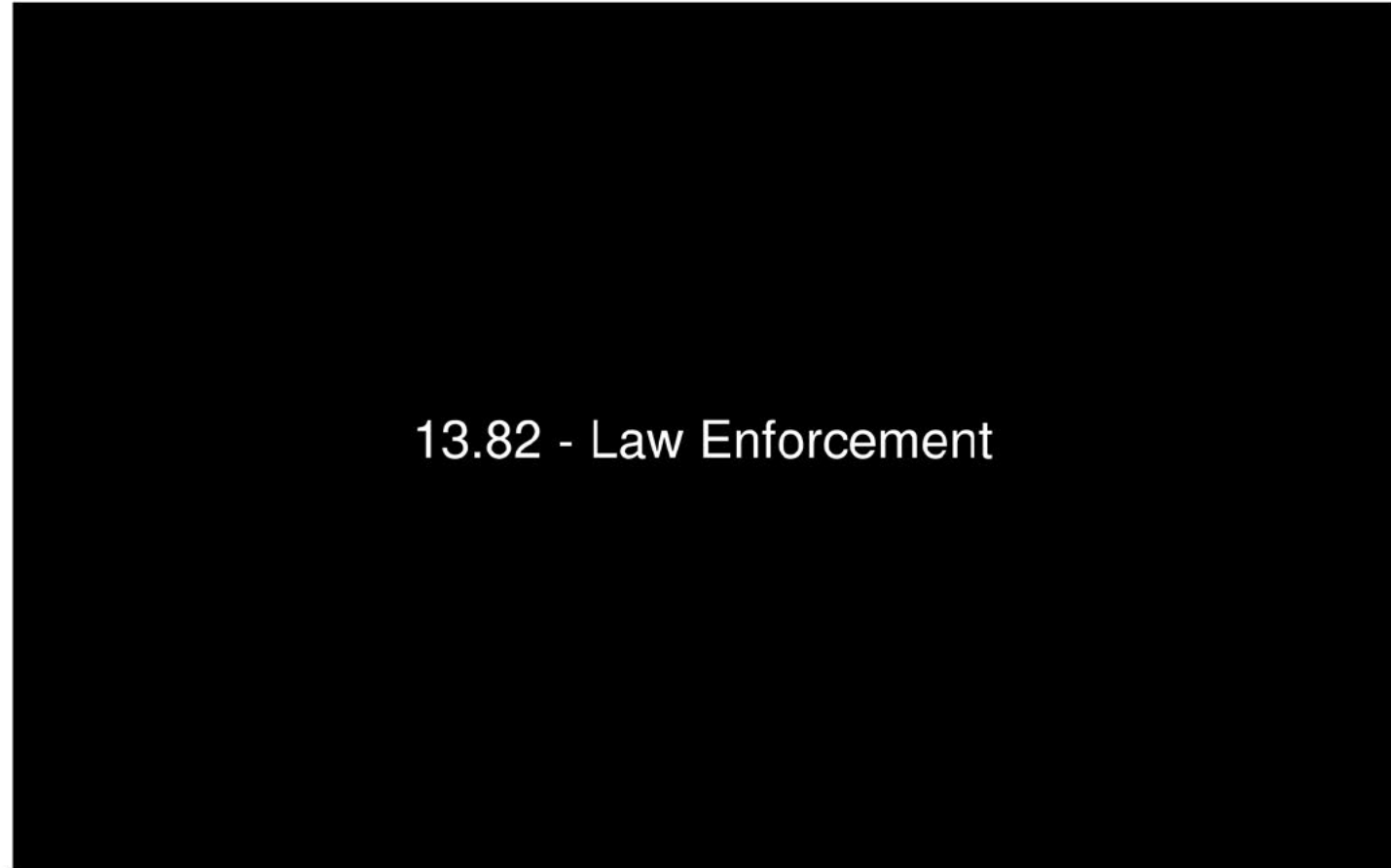

At approximately 5:15 p.m. on May 30, 2024, Minneapolis Police received a call of two people shot inside an apartment on the 2200 block of Blaisdell Ave. S. Officers from Minneapolis Police's Fifth Precinct responded and the suspected shooter opened fire on the officers. Minneapolis Police officers exchanged fire with the suspect, and two officers and the suspect were injured during the gunfight. The suspected shooter died at the scene despite lifesaving efforts. One officer sustained an apparent non-life-threatening injury, and another received life-threatening injuries. Both officers were transported to Hennepin County Medical Center (HCMC). One officer was treated and released. The second officer, identified as Officer Mitchell, died of his injuries at the hospital.

Officers searching the apartment building located two individuals, who may have been residents of the building, apparently injured by gunfire. One of these individuals, an adult, was found deceased in the apartment. The other individual, also an adult, was transported to HCMC with life-threatening injuries.

Outside the apartment, another adult male was found shot while in his vehicle. He was transported to HCMC with life-threatening injuries. A Minneapolis firefighter also received a non-life-threatening injury during the incident. They were taken to the hospital where they were treated and released.

Forensic scientists from the Minneapolis Police Forensic Division responded to process the scene and collect evidence. Homicide detectives responded to begin an investigation.

Minnesota Bureau of Criminal Apprehension (BCA) investigators are working with MPD investigators to determine the circumstances surrounding the shooting deaths.
