LETTER OF AGREEMENT

Recovery of Overpaid Wages

WHEREAS the City of Minneapolis ("City") and AFSCME Council 5, Local 9 ("Union") (collectively "the Parties"), are parties to a collective bargaining agreement currently in effect;

WHEREAS an audit of City Payroll records revealed that at various times since June 25, 2017, (start of the pay period that included July 1, 2017) the City mistakenly overpaid wages to 32 employees then represented by AFSCME, identified on Exhibit A, attached hereto and incorporated herein by reference;

WHEREAS two of the identified employees are no longer represented by AFSCME;

WHEREAS the overpayments occurred because the City applied incorrect anniversary/ step advancement dates, which caused early step increases, resulting in overpaid wages;

WHEREAS the City has since corrected the incorrect anniversary/step advancement dates;

WHEREAS on or about March 19, 2019, the City discussed the errors with AFSCME;

WHEREAS on or about March 25, 2019, the City notified each employee identified on Exhibit A of the amount of the employee's overpaid wages, including the dates during which those overpayments occurred, indicating it would work with the Union to reach agreement on a method of repayment;

WHEREAS to reduce the financial impact on employees, the City provided several options from which employees could chose to repay the City;

NOW THEREFORE THE PARTIES HERETO AGREE AS FOLLOWS:

- 1. Beginning with the pay period of June 23, 2019, for all employees identified on Exhibit B, the City is authorized to deduct an amount equivalent to every contractual wage increase and step increase, until the City has recovered the full amount of the overpaid wages;
- 2. Prior to June 23, 2019, employees identified on Exhibit C had repaid to the City the amount of overpaid wages;
- 3. Four employees selected paycheck dates on which the City has deducted the amount of the overpayment from their paychecks, identified on Exhibit D;
- 4. One employee elected to pay a specific amount through payroll deduction until the overpaid balance reaches zero, identified on Exhibit E;
- 5. If any employee leaves City employment, for any reason, before the City has fully recovered the amount of the overpayment, the City may deduct from that employee's final paycheck any remaining amount;
- 6. In the event of any newly discovered wage overpayments to AFSCME members on or before December 31, 2020, for more than \$100, the City will offer the following repayment options:
 - a. Full payment to the City;
 - b. Payroll deduction of the full amount on a specific agreed-upon date;
 - c. Payroll deduction of a specified sum on every paycheck until the overpayment is fully recovered;
 - d. Payroll deduction of a sum equal to future step and contractual increases until the overpayment is fully recovered.

For overpayment amounts less than \$100, the City may its sole discretion offer the above options but is not obligated to do so. After December 31, 2020, the City may in its sole discretion offer the above options but is not obligated to do so.

This Letter of Agreement is effective retroactive to the dates specified herein upon the signature of the Parties' authorized representatives below.
