Emerald ash borer yog dabtsi?

Emerald Ash Borer (EAB) yog ib hom kab heev uas noj cov ntoo "ash" tuag. Nws muaj nyob hauv Minneapolis thiab tej zaum muaj nyob tagnrho cov zos hauv nroog Hennepin. Feem ntawv txhua tsob ntoo "ash" nyob hauv Minneapolis yeej kis lawm yog hais tias tsis tau tsuag tshuaj rau nws. Nws yuav yog li ob peb xyoo mas li pom cov qauv thiab/lossis cov tsos kab noj tsob ntoo "ash", ces txawm hais tias tsob ntoo zoo li tsis ua li cas, los tej zaum nws twb kis lawm.

Nws muaj ntawv hom ntoo "ash" hauv Minneapolis – ntsuab, dawb, thiab dub. Ntawm no qhia kom koj paub tsob ntoo "ash" zoo li cas:

Kuv ua tau dabtsi?

- Tsuag tshuaj rau koj tsob ntoo: cov ntoo "ash" muab tshuaj tsuag kho tau, tiamsis yog hais tias twb pomcov kab EAB noj tsob ntoo lawm, tej zaum lig dhau lawm tsuag tshuaj yuav tsis pab. Tsuag tshuaj rau tsob ntoo yuav tsis kim npaum li muab nws txiav pov tseg. Tsuag tshuaj ob peb xyoo ib zaug los yuav lav tsis tau tias tsob ntoo puas tseem yuav ciaj. Tiv tauj ib tug neeg kawm txawj txog ntoo ISA-Certified Arborist seb tsuag tshuaj rau koj tsob ntoo puas zoo. Mus saib www.minneapolismn.gov/tree-contractors daim ntawv muaj cov neeg kawm txawj txog ntoo hauv Minneapolis.
- Txiaiv tsob ntoo: yog kab noj ntawv dhau lawm lossis tsuag tshuaj tsis pab, yuav tau muab nws txiav pov tseg.
- Cog tsob ntoo tshiab: tom qab muab tsob ntoo "ash" kab noj txiav lawm, koj cog tau ib tsob ntoo tshiab

Emerald Ash Borer nyob hauv Minneapolis

Cov qauv thiab tsos kab noj tsob ntoo emerald ash borer zoo li cas?

- Tsob ntoo tuag zuj zus: cov nplooj saum toj lossis ib ceg ntoo pib tuag zuj zus, ces yuav kis tagnrho rau tsob ntoo
- Cov menuam ntoo tuaj ntawm hauv paus ntoo: pom tau tias cov ntoo hlav tshiab tuaj ntawm cag lossis hauv paus ntawm tsob ntoo tsis zoo
- Muaj cov noog “woodpecker” tuaj noj coob: woodpeckers thos tsob
- Tsob ntoo daj zuj zus: qhov tawv ntoo dawb tej thaj lossis thoob yuav tas tsob ntoo vim cov noog woodpeckers thos mus noj cov menuam kab nyob hauv
- Tawv ntoo tawg pleb lossis tej daim tawv ntoo ntais: cov menuam kab khawb qhov hauv qab qhov tawv ntoo ua rau nws tawg thiab/lossis ntais
- Kab qauv txaij li tus nab hauv qab daim tawv ntoo: menuam kab ua cov kab qauv txaij li tus nab nyob rau daim tawv ntoo
- Cov qhov me tawm sab nraum zoo li tus D: cov kab pib nyug laus ua cov qhov me me zoo li tus D thaum lawv tawm tsob ntoo mus sab nraum.
